REGULAR CALLED SESSION  
FEBRUARY 11, 2020**

Be it remembered that the Henderson County Commission met for a Regular Called Session on February 11, 2020 at 7:00 P.M.

Commissioner Harold Tyler gave the Invocation.

Commissioner Tommy Page led the Pledge of Allegiance.

Item I. Motion made by Commissioner Andy Anderson, seconded by Commissioner Aaron Wood to approve the Minutes of January 14, 2020 Minutes with a correction of Item III to say that it was approve by prior Commissioners. Motion carried.

Item II. Motion made by Commissioner Terry Allen, seconded by Commissioner Blake Stanfill to approve Wanda J. Armstrong, Angela G. Deere, Mary C. Jowers, Mack Maness, Jr., Jill Middleton, Donna Moody, Anita W. Mullins, Gloria J. Warren, and Kim Williams as Notaries.

Item III. Motion made by Commissioner Joe Ross, seconded by Commissioner Todd Beecham to approve the Resolution for the Community Development Block Grant for the Fire truck. Motion carried.

Item IV. Motion made by Commissioner Todd Beecham, seconded by Commissioner Blake Stanfill to approve the Resolution of Henderson County declaring support for the Second Amendment of the United States Constitution. Motion carried.

Item V. Motion made by Commissioner Tommy Page, seconded by Commissioner Wanda Powers to do away with all the fee offices. Motion carried by a vote of 9 ayes and 5 nays (Commissioners Jeff James, Harold Tyler, Aaron Woods, Terry Allen, and Andy Anderson).

Item VI. Motion made by Commissioner Aaron Wood, seconded by Commissioner Tommy Page to raise the Wheel tax \$40.00 for the General Fund and \$5.00 for the Solid Waste making a total of \$45.00 increase in Wheel Tax. Motion carried by a vote of 10 ayes and 4 nays (Commissioners Jeff James, Blake Stanfill, Terry Allen, and Andy Anderson).
